## 1. Parent-School Agreement

- All parents are required to sign a Parent-School Agreement upon enrolment and annually thereafter.

## 2. Parent Code of Conduct

In line with ADEK requirements, parents are expected to:

  - Support their child's learning by ensuring good attendance, punctuality, healthy routines, and academic honesty.
  - Communicate respectfully with staff and use designated channels for concerns.
  - Promote positive digital behaviour and refrain from posting defamatory or culturally insensitive content online.
  - Respect UAE cultural values and dress codes during school visits and events.

## 3. Engagement Strategies

To strengthen school-parent partnerships, Al Rabeeh School will:

- Provide **Parent Induction Sessions** for new families.
  - Share **regular updates** via iSAMS Parent Portal, Class Dojo, newsletters, and meetings.
  - Conduct **parent workshops** on curriculum, wellbeing, safeguarding, digital safety, and cultural identity.
  - Hold **coffee mornings** and open days for dialogue and community building.
  - Establish a **Parent Council and Governing Body representation**, ensuring parents are involved in strategic and operational school improvement.
  - Provide **termly parent surveys** to capture feedback on learning, wellbeing, and engagement.

## 4. Parents' Role in Learning and Wellbeing

Parents will be actively engaged in:

- Understanding their child's curriculum, assessment results, and next steps.
  - Supporting home learning and digital safety.
  - Contributing to their child's individual learning plans, particularly for Students of Determination and gifted/high-achieving students as per the ADEK Inclusion Policy. For compliance, any students receiving additional support will be added to the Additional Learning Needs System.
  - Promoting healthy eating, wellbeing, and positive mental health practices at home.
  - Supporting student participation in extracurricular and cultural activities.

## **5. Communication**

- The school will use multiple communication channels (email, portal, newsletters, meetings) and ensure accessibility in both Arabic and English.
  - Response times and emergency contact protocols will be clearly communicated to parents.
  - Parents will receive timely student progress reports and at least one parent-teacher meeting each term.

## **6. Parent Conduct and Misconduct**

- Misconduct will first be addressed through dialogue.
  - Continued concerns may result in formal written notification.
  - Serious breaches may lead to restricted access to school premises and/or referral to ADEK in line with regulations.
